Many people falsely believe that the Bible and Christianity are "anti-science."

This is not true.

In fact, the Bible commands that science be practiced, as Adam and Eve are told to "subdue" and "rule over" the earth.

To subdue something you need to understand it, and the understanding of nature is a good definition of science.



It is generally acknowledged that most of modern science was founded by Christians. Christianity allowed science to flourish due to its tenet that God upholds the world in a consistent manner, and that there are not spirits inhabiting things, which would prohibit their probing.

## Everyone is biased!



So how can the views of Genesis be true when secular scientists say the opposite?

After all, either we got here by creation or by an evolutionary process.


Either there was or was not a global flood in our past.

The answer is that the interpretation of facts/data can be and is frequently different depending on your starting assumptions, or your “worldview.”

Secular scientists and historians who have been taught an evolutionary worldview will try to fit all data into that framework.

The creation scientist has the same data, but understanding that God exists and knowing the history of Genesis, may reach a very different interpretation.



# Genesis interpretations



Because of the obvious conflicts between the histories of Genesis and secular science, theologians and others have developed a number of theories in an attempt to resolve the conflicts.


Their main goal is to retain both the validity of modern science and the validity of the Bible.

However, I would argue that these reinterpretations of Genesis are not needed and that it is the interpretations of secular science that are in question.

It is possible to explain the scientific-historical facts in a cohesive and satisfying manner through a straightforward biblical worldview, as is the premise of "Young Earth Creationism."

- Gap Theory – there was a long period of time between Genesis 1:1 and 1:2, when the fossil record was laid down. It is also called the "ruin and reconstruction" theory with Genesis 1:2 starting the reconstruction. The effects of the flood are minimized.
- Day-Age Theory – each "day" of Genesis chapter 1 was a long period of time, many millions of years.
- Progressive Creation – God stepped into the world to create new, more advanced, sets of creatures from time to time, separated by millions of years. There were "pre-men". The flood was just a local event.
- Theistic Evolution – basically the same as secular evolution except that God is said to have been driving it along. However, true evolution is defined as an "unguided" process.
- Intelligent Design – this more recent movement looks to convince people that the scientific evidence points to a designer. But it does not say who the designer is, and makes no claims concerning the Bible or Genesis.
- Framework Hypothesis – Genesis is not to be taken literally, but has a simple purpose to show that God was the creator.

-- *Genesis 1:1*




The most basic doctrine of Christianity is that God is real and that He is the creator.

- "It can be truly said that we all are here today because of quantum fluctuations in what is essentially *nothing*."
- "In this sense, science ... does not make it impossible to believe in God, but rather makes it possible to not believe in God."

Atheists want to convince people that this most basic idea that God exists is not necessary.

In the Lawrence Krauss best-selling book "A Universe from Nothing," he tries to show how the universe might have arisen on its own.

But in the end there is no getting away from the fact that the universe must have been caused by something/someone, to which we give the name "God."

# Multiverse Theory

- The idea that there may be an almost infinite number of universes, each having different laws of physics
- We happen to live in one "just right" for life



Used to avoid the "fine-tuning" problem, that our universe and Earth seem to be special

The existence of our finely-tuned universe and the specialness of the earth can no longer be denied by secular scientists.

But instead of acknowledging God, their answer today is that there must be an essentially infinite number of universes, and we just happen to live in the rare or only one which has the right properties for life. However, this is not science (which is observable and repeatable, and the existence of other universes could never be proved) but rather science fiction!

## Man created in the image of God



**Man is not an animal!**

So God created mankind in his own image,  
in the image of God he created them;

The next foundational doctrine is that man was created in the image of God.

He is therefore different from, and is not, an animal.

We share many biological similarities with animals because we both need to live in the same environment.

## Marriage of man and woman





Many people, even Christians, have doubts about the accuracy of Genesis. But as we have seen, this is where many important doctrines have their origin, and if Genesis cannot be believed as accurate, then why should the rest of the Bible be trustworthy?

**Genesis is real history**



We now turn to the second topic of “why Genesis?”, which is that it describes real history not “stories.”



"Where were you when I laid the earth's foundation? Tell me, if you understand."  
-- Job 38:4 (God speaking to Job)

The Bible has the only eye-witness account  
of our beginnings!

The Bible gives the only eye-witness account of our beginnings.  
No secular scientist was there and so any of their conjectures as to our beginnings are really just speculations which assume things have always worked as they do now.

## Creation over 6 days 6,000 years ago



Genesis describes the creation as taking six days.

The most straightforward interpretation is that these are actual 24-hour days.

For those having a “millions of years” worldview this idea of creation in six days is ridiculous.

However, if God really exists, we might ask “why did He take so long?”, as could have created in an instant.

The answer is that He wanted to model a work-week for us.

An important point to remember about the creation week is that it was a miracle.

The extent to which current physics and physical processes were involved is unknown and unknowable.

However, it seems some sequencing of actions took place over the six days.

At the completion of the creation week everything existed in a mature state, ready for its intended purpose.

Adam was not created as a baby.

God did not sow seeds to create the Garden of Eden.

By its very nature a mature creation will have an appearance of age.

It must be this way.

Adam looked to be about 15-20 years old.

Trees looked to be tens or even hundreds of years old.

Some rocks were likely rounded as if shaped by the action of water.

It is this consistent apparent age that secular scientists are measuring when they claim the earth is 4.5 billion years old.

## Mature creation

- The mature creation concept has a rich history with Bible scholars
- The universe was created mature and ready to serve its purposes
- The original biosphere was mature and ready for use
- We can see distant starlight because it was created “in transit”



Recognizing a mature creation explains many of the apparent conflicts between Genesis and secular science. Some people say that God is fooling us with physical processes that indicate long ages, but He told us what He did.

**If it could be demonstrated that any complex organ existed, which could not possibly have been formed by numerous, successive, slight modifications, my theory would absolutely break down. But I can find out no such case.**



The most debated question of our history is whether we were directly created as stated in Genesis, or did life evolve through some gradual process?

First of all, if God has used an evolutionary process He would have told us so and that would have been fine. But the actual evidence is that evolution not only has not taken place, but is scientifically impossible.

Charles Darwin recognized that if even one living thing could not have evolved, then evolution did not happen.




A well known and straightforward example showing the impossibility of evolution is the life cycle of the Monarch Butterfly.

If the caterpillar cannot transform itself through the Chrysalis stage in one generation, it is the end of the line for the butterflies.

The Chrysalis transformation is so complex that scientists even now are only starting to understand how it works.

# Molecular machines

It is one thing to believe in Darwin's time that evolution might be possible, when people understood the cell as basically a blob of jelly ("protoplasm").


However, today we know that the cell is like a miniature factory, having many active processes.

Did you know that in every cell there are nano robots, called Kinesin, which travel down "roads" carrying cargo from one part of the cell to another?

It is impossible to even imagine how such a thing might develop on its own in a gradual manner.

## Irreducible Complexity: Take away one part and it doesn't work

Another aspect of the scientific impossibility of evolution is the need for all the components of a complex system to be in place and working together at the same time.

This idea is called “irreducible complexity” and a simple example of it is the old fashioned mouse trap. Unless all of the parts are present and in the proper position, no mice will be caught.

- Matter on its own developed the concept of love.


All of these ideas are absurd.



# Man existed with dinosaurs!

Most people don't know this, but the Bible describes dinosaurs and that men knew of them. In the book of Job, God says the creature He is describing "ranks first" among His works. This is a apt description of the large dinosaurs, which dwarf all of the creatures alive today.



However, the evolutionary worldview that dinosaurs died out 65 million years ago has even affected our Bible translators!

They are forced to equate Behemoth with a hippo or an elephant, which clearly don't have the massive tail which God describes.



Dinosaurs were created on Day 6.  
Juvenile dinosaurs were taken on the ark.  
Dinosaurs are the well-known “dragons” of history.  
Environmental conditions and people eventually killed them off.

The word “dinosaur” was not coined until the year 1841 and so was not available for use in the original English version of the Bible, the King James (completed in 1611).





In Genesis we see Adam created as perfect - he had high intelligence and already possessed knowledge.


This is illustrated in his naming of the animals.

All fossil skulls can be classified as either ape or human, which is why the secular search for the "missing link" continues.


## Nine generations alive together



Most people don't realize that due to the long life spans before the flood, almost all of the generations prior to the flood were alive at the same time.

What this means is that it was easy for Noah to learn about and record or bring along information from Adam about the Garden of Eden and the fall.

## The Flood



We now turn to the global flood of Noah's time.

This is the biggest geological event since the creation.

Although it is not believed by modern secular geologists, there is in fact much physical and other evidence for it.

At a high level, what would we expect from a global flood?

Well, we would expect what is said on this slide, and that is exactly what we find when we dig.

It has been said that if the Bible did not describe a global flood, we would have to infer one, because it is needed to explain the geologic column and its fossils.




Even most Christians do not properly understand the flood.  
It is portrayed for children as almost a “happy time at the zoo.”  
It is frequently thought of as just “a story” to each a moral lesson and is rarely given a serious treatment.



However, Genesis gives an historical narrative that paints a frightening picture of the extreme wickedness of man which results in an extreme judgment by God – a global flood which destroyed most living things. God is even said to be “sorry” that He created man (Genesis 6:6). Noah and his three sons and their wives, along with representative animals, were all who survived.

# The Cambrian Explosion

## The fossil record supports creation not evolution



The geologic evidence fits the flood perfectly.

The pre-Cambrian rock layer has essentially no fossils while the immediate covering layer, the Cambrian, contains fossils of every major body plan.

This is called the “Cambrian Explosion” and is where the flood strata start.

The geologic column does show a general progression of simpler to more complex organisms. However, this is not the result of evolution over millions of years, but rather is what you would expect from a global flood, as smarter and more mobile creatures escape the waters longer before being buried.

## Polystratic Fossils

It is obvious that the rock layering did not take place over millions of years, as we find the fossil remains of single trees extending through many layers.

## Cambrian Explosion Trilobites



Even the oldest creatures found in the Cambrian layer are quite advanced, such as the trilobite which has complex eye optics.

All creatures found in the fossil record are already fully formed.

The intermediate forms expected by evolution are not found.

# Living Fossil: Coelacanth Fish

When we compare living examples with creatures found as ancient fossils, we see that no evolutionary change has taken place.



The eruption of Mt. St. Helens in 1980 carved a 1/40<sup>th</sup> scale Grand Canyon in a matter of days or even just hours in some areas, and produced rock layering. It shows that the layers are the result of pulsing in the water and mud flow, and do not necessarily represent the progression of yearly weather cycles.



After the flood the people gathered together to build a city, contrary to God's desire to have them repopulate the entire earth.


God intervened and confused their language so that they could not work together anymore and were forced to move on.

This event explains why we have different languages and different people groups around the world.

Inbreeding in small migrating populations would cause certain physical characteristics to become dominant in that area of the world, which explains why we have different "races."


However, according to the Bible, there is really only just one race, the human race, and there is no justification for racism in any form.

# Worldwide flood traditions



It is interesting, but expected if the flood is true, that cultures around the world would have a memory of this event, and they do, although distorted to varying degrees. Over 250 flood traditions have been documented. This cannot be a coincidence.


## Amazing technology of early civilizations

Most of us are familiar with some of the amazing things which ancient civilizations accomplished, such as the pyramids in Egypt and elsewhere, the Nazca desert drawings, and the moving and carving of very large stones. These are not a surprise from a biblical worldview, as the high intelligence and skills of Adam and Eve would have been carried through the flood and into the first post-flood civilizations.

- Shows the accuracy of Genesis chapters 10 (The Table of Nations) and 11 (genealogy from Shem to Abram)





- They mapped all the continents, and Antarctica was mapped when its coasts were free of ice




